NLPA SAVES 65 YEARS IN PRISON FOR OUR CLIENTS IN 2015

During 2015, NLPA continued its excellent record of helping defendants receive successful outcomes in their cases. The research NLPA has prepared in the first quarter of 2015, has helped saved collectively more than 55 years in prison for our clients. Here is a list of those cases.

Akil Tymes: NLPA assisted Mr. Tymes in obtaining a prison transfer in the State of Florida. Mr. Tymes was being threatened by other inmates in his current facility. With NLPA's assistance, Mr. Tymes was moved to another prison securing this safety.

Randall Lee Daniels: NLPA assisted Mr. Daniels' attorney in the preparation of research for his sentencing. His case was heard in the USDC, Dist of SC (3:04-cr-00132). The PSI recommended a sentence 360 months. However, the court instead imposed 288

months - **saving Mr. Daniels six years in prison.**

Lofton Clark: NLPA assisted Mr. Clark's attorney in the preparation of research for his sentencing. His case was heard in the USDC, District of KS, 5:13-cr-40034-JAR-1. The PSI recommended a sentence of 140 months. However, the court instead imposed 130 months - **saving Mr. Clark ten months in prison.**

Robert Rios: NLPA assisted Mr. Rios' attorney in the preparation of research for sentencing. His case was heard in the USDC, WDPa, 2:13-cr-00252. The PSI recommended a sentencing range of 57-71 months. However, the court imposed 30 months - **saving Mr. Rios more than three years in prison.**

Chandra Ross: NLPA assisted Ms. Ross' attorney with research for her sentencing. Her case was heard in the USDC, SDWV, 2:13-cr-00213. The PSI recommended a sentencing range of 130-157 months. However, the court instead imposed 84 months - **saving Ms. Ross more than six years prison.**

Donald Whitten: NLPA assisted Mr. Whitten's attorney in the preparation of research for his sentencing. His case was heard in the USDC, WDPa, 2:13-cr-00216-CB-1. The PSI recommended a sentencing guideline of 120 months. However, the court instead imposed 46 months - **saving Mr. Rios more than six years in prison.**

Hector Rengifo: NLPA assisted Mr. Rengifo's attorney in the research for his sentencing. His case was heard in USDC, MDPa, 1:13-cr-00131. The PSI recommended a sentencing range of 151-188 months. The court instead imposed 120 months - **saving Mr. Rengifo more than 5 years in prison.**

Samuel Raphael Johnson: NLPA assisted Mr. Johnson's attorney in the preparation of research for his sentencing. His case was heard in the USDC, WDMO, 2:12-CR-04008. The PSI recommended a sentencing guideline range of 20 years to life. However, the court instead imposed 180 months - **saving Mr. Johnson more than 15 years in prison.**

John Randy Callihan: NLPA assisted Mr. Callihan's attorney in the preparation of research for his sentencing. His case was heard in the USDC, SDOH, 1:12-CR-00054. The PSI recommended a sentencing guideline range of 188-235 months. However, the court instead imposed 60 months - **saving Mr. Callihan more than 14 years in prison.**

Marcus Alberty: NLPA assisted Mr. Alberty's attorney in the preparation of research for his sentencing. His case was heard in the USDC, NDTX, 3:14-cr-00007. The PSI recommended a sentencing guideline range of 180-188 months. However, the court instead imposed 90 months - **saving Mr. Alberty more than eight years in prison.**

Charles Prewitt: Mr. Prewitt pled guilty in USDC, Eastern District of Louisiana in a drug conspiracy case. NLPA assisted Mr. Prewitt's attorney **in a successful appeal of the denial of this \$3582 motion.**

Reemal Kumar Patel: NLPA assisted Mr. Patel's attorney in the preparation of research for his sentencing. His case was heard in the USDC, SDFL, 9:12-cr-80105-003. The PSI recommended a sentencing guideline of 87 months. However, the court instead imposed 70 months - **saving Mr. Patel 17 months in prison.**

Keith A. Johnson: NLPA worked with Mr. Johnson's attorney to reinstate his appeal rights. His case was heard in the State of Ohio #26028. **Mr. Johnson won the right to appeal the decision in his case.**

Angel Munoz-Escalante. NLPA worked with Mr. Munoz-Escalante's attorney to secure an **early release into the CTC placement.**

Tammy Valdez : NLPA assisted Ms. Valdez's attorney in the preparation of research for her sentencing. Her case was heard in the USDC, SDFL. The PSI recommended a sentencing guideline range of 63-78 months. However, the court instead imposed 42 months - **saving Ms. Valdez three years in prison.**

Ralph Valdez : NLPA assisted Mr. Valdez's attorney in the preparation of research for his sentencing. His case was heard in the USDC, SDFL. The PSI recommended a sentencing guideline range of 63-78 months. However, the court instead imposed 60 months - **saving Mr. Valdez one and half years in prison.**

Terran Price: NLPA assisted Mr. Price's attorney for his sentencing. His case was heard in the USDC, EDKY. The PSI recommended a sentence of 235 months. The court instead imposed 132 months - **saving Mr. Price eight and half years in prison.**

Kylr C. Yust : NLPA assisted Mr. Yust's attorney in the preparation of research for his sentencing. His case was heard in the USDC, WDMO 4:12-cr-00239. The PSI recommended a sentencing guideline range of 70-87 months. However, the court instead imposed 45 months - **saving Mr. Yust three and half years in prison.**

Courtney Dupree : NLPA assisted Mr. Dupree's attorney in the preparation of research for his sentencing. His case was heard in the USDC, Eastern District of New York Missouri 1:10-cr-00627-1. The PSI recommended a sentencing guideline range of 135-168 months. However, the court instead imposed 84 months - **saving Mr. Dupree seven years in prison.**

Wilbur Avalos-Perez: NLPA was able to assist Mr. Avalos-Perez and his attorney in **forcing the BOP to provide necessary medical treatment.**

Omar Moreno Phillips: NLPA assisted Mr. Phillips's attorney in the preparation of research for his sentencing. His case was heard in the USDC, District of SC 4:13-cr-00314-1. The PSI recommended a sentencing guideline range of 235-293 months. However, the court instead imposed 105 months - **saving Mr. Phillips 15 and half years in prison.**

Delbert Lamone Dailey: NLPA assisted Mr. Dailey's attorney in the preparation for his sentencing. His case was heard in the USDC, NDTX 4:13-cr-00169-2. The PSI recommended a sentencing guideline range of 292-365 months. However, the court instead imposed 120 months - **saving Mr. Dailey 20 years in prison.**

Rodney Moore: NLPA assisted Mr. Moore's attorney in the preparation of research for his sentencing. His case was heard in the Sixth Circuit Court of Appeals (#11-5550). The PSI recommended a sentencing guideline range of 360 months to life. However, the court instead imposed 144 months - **saving Mr. Moore at least 18 years in prison.**

Dewayne Joseph: NLPA assisted Mr. Joseph's attorney in research for his sentencing. His case was heard in the Court of Appeals for the Sixth Circuit (#11-5664). The PSI recommended a sentencing guideline of 240 months. However, the court instead imposed 120 months - **saving Mr. Joseph 10 years in prison.**

Ditanial Hairston: NLPA assisted Mr. Hairston's attorney in the preparation of research for his sentencing. His case was heard in the USDC, WDVA. The PSI recommended a sentence of 140 months. However, the court imposed 120 months - **saving Mr. Hairston one and half years in prison.**

Ogiesoba City Osula: NLPA assisted Mr. Osula's attorney in the preparation of research for his sentencing. His case was heard in the USDC, NDTX. The PSI recommended a sentencing guideline of 324-405 months. However, the court instead imposed 240 months - **saving Mr. Osula almost 14 years in prison.**

Hector Galvan: NLPA assisted Mr. Galvan's attorney in the preparation of research for his sentencing. His case was heard in the USDC, EDTN. The PSI recommended a sentencing guideline range of 87-102 months. However, the court instead imposed 60 months - **saving Mr. Galvan three and half years in prison.**

Gregory Ward: NLPA assisted Mr. Ward's attorney in the preparation of research for his sentencing. His case was heard in the USDC, EDLA. The PSI recommended a sentencing guideline range of 262-327 months. However, the court instead imposed 236 months - **saving Mr. Ward seven and half years in prison.**

Bryant Reynolds: NLPA assisted Mr. Reynolds' attorney in the preparation of research for his sentencing. His case was heard in the USDC, WDVA. The PSI recommended a sentencing guideline range of 188-235 months. However, the court instead imposed 108 months - **saving Mr. Reynolds 10 and half years in prison.**

Nabrasker Burnhart: NLPA assisted Mr. Burnhart's attorney in the preparation of a writ of mandamus to **secure a government-paid expert witness** for Mr. Burnhart's trial defense.

The PSI recommended a sentencing guideline range of 324-384 months. However, the court instead imposed 240 months - **saving Mr. Doctor 12 years in prison.**

The PSI recommended a sentencing guideline range of 188-235 months. However, the court instead imposed 212 months - **saving Mr. Gonzalez almost two years in prison.**

Stephen Williams: NLPA assisted Mr. Williams' attorney in the preparation of research for his sentencing. His case was heard in the USDC, District of Columbia. The PSI recommended a sentencing guideline range of 84-105 months. However, the court instead imposed 70 months - **saving Mr.**

Williams almost three years in prison.

Robert Curtis Rigsby: Mr. Rigsby pled guilty to USDC, SDOH in a child pornography case. NLPA was able to assist Mr. Rigsby in **obtaining placement into a Residential Re-Entry Center.**

Renata Galvan: NLPA assisted Ms. Galvan's attorney for her sentencing. Her case was heard in the USDC, EDTN. The PSI recommended a sentencing guideline range of 75-87 months. However, the court instead imposed 60 months - **saving Ms. Galvan more than two years in prison.**

Rondale McCann: NLPA assisted Mr. McCann's attorney in the preparation of research for his sentencing. His case was heard in the USDC, EDKY. The PSI recommended a sentencing guideline range of 288-360 months. However, the court instead imposed 192 months - **saving Mr. McCann 14 years in prison.**

The PSI recommended a sentencing guideline range of 352-425 months. However, the court instead imposed 180 months - **saving Mr. Williams 20 years in prison.**

Jeremy Wayne Perkins: NLPA assisted Mr. Perkins' attorney in the preparation of research for his sentencing. His case was heard in the USDC, SDTX. The PSI recommended a sentencing guideline range of 292-365 months. However, the court instead imposed 151 months - **saving Mr. Perkins more than 17 years in prison.**

Azim Showell: NLPA assisted Mr. Showell's attorney in the preparation of research for his sentencing. His case was heard in the USDC, MDPA. The PSI recommended a sentencing guideline range of 151-188 months. However, the court instead imposed 147 months - **saving Mr. Showell more than three years in prison.**

Marco Antonio Gonzalez: NLPA assisted Mr. Gonzalez's attorney in the preparation of research for his sentencing. His case was heard in the USDC, SDTX. The PSI recommended a sentencing guideline range of 168-210 months. However, the court instead imposed 72 months - **saving Mr. Gonzalez more than 11 years in prison.**

Arthur Hollis: Mr. Hollis was convicted in USDC, District of Alaska of distribution of cocaine and sentenced to 20 years. Despite the objections by the prosecutor, NLPA was able to assist Mr. Hollis' attorneys in **granting his Certificate of Appealability.**

Glenn Richards: NLPA assisted Mr. Richards' attorney during plea negotiations. Despite the government's request for a 15 year sentence, NLPA and his attorney were able to secure a sentence of just 5 years - **saving Mr. Richards ten years in prison.**

Mirwaiss Aminzada: NLPA assisted Mr. Aminzada's attorney in **securing three continuous delays of his reporting date** allowing Mr. Aminzada to receive necessary medical treatment.

NEW LAWS TO REINSTATE PAROLE, RELEASE ELDERLY INMATES & INCREASE GOOD TIME FOR 2016

Good News! There are two sentencing/prison reform bills in Congress that may become law in 2016: Senate Bill 2123 (The Sentencing Reform and Correction Act) and House of Representative Bill 3713.

The Senate Bill increases good time from the current 15%, provides for early release of elderly inmates who are at least 60 years old and reinstates parole. It has been approved by the Senate Judiciary Committee but still must be passed by the Senate and signed by the President before it can become law. President Obama has stated that he will sign this Bill when it is passed by Congress.

House of Representative Bill 3713, the Sentencing Reform Act, contains sentencing reform to reduce mandatory minimum sentences. It has been approved by the House Judiciary Committee. But, like the Senate Bill, must also be passed by the Congress and signed by the President to become law.

NLPA does not know when (or if) either Bill might become law. But, NLPA will continue to monitor the new laws and let you know any latest developments.
